

# **College Credit Plus Program**

# **ELIGIBILITY:**

Your child must be a bona fide seventh grader, eighth grader, freshman, sophomore, junior, or senior for the year in which participation is sought. In addition, your child must meet the college's or university's standards for admission and course placement.

A student who has been expelled by Patriot Preparatory Academy is ineligible to enroll during the period of expulsion. Patriot shall deny high school credit for College Credit Plus courses any portion of which is taken during the period of a student's expulsion. If the student has elected to receive both high school and college credit that election is automatically revoked for all the college courses in which the student enrolled during the college term in which the expulsion is imposed.

The institutions of higher education to which the College Credit Plus program applies are: both public colleges as defined in R.C. 3365.01 and participating private colleges as defined in R.C. 3365.01.

## **ENROLLMENT:**

By April 1st of each year, you and your child must complete and submit the "Letter of Intent to Participate in College Credit Plus" form which signifies a student's intent to participate in the program for the following school year. Prior to completing this form, you and your child must understand the following associated with this program:

- A. Must apply and be accepted to college by May 1st.
- B. This program does require extra studying time on the part of the student.
- C. Only students in 11th or 12th grade may request taking college classes off campus during the school day and transportation is the responsibility of the family.
- D. In order for a student to remain on campus when they do not have a CCP class they must make arrangements with the school during the semester registration and be placed in a specific classroom.
- E. When scheduling CCP classes, students' high school course requirements are a priority.



# **PARTICIPATION:**

Participation is contingent upon admission to the college or university. Patriot will assist your child in gaining admission by providing transcripts and other related documents, but will accept no responsibility if he/she is NOT accepted by the college or university. Your child, if awaiting acceptance, should register for classes at Patriot as if he/she were not participating in the program. Schedule changes will then be made prior to the start of each semester if your child receives notice of admission.

If your child withdraws from the college class for high school credit within the first two (2) weeks of the college course, he/she will be re-enrolled in high school classes.

Reasonable efforts will be made in scheduling to accommodate the needs of your child when leaving the high school campus in order to participate in this program. However, scheduling conflicts are not the responsibility of Patriot. Revising the master schedule and/or unduly overloading classes will not be done in order to accommodate schedule requests.

Continued participation is contingent upon the student remaining in good academic standing. Student's put on probation must abide by stated policy to bring up their GPA. Student's who do not remain in good standing will be dismissed from the program, as per our policy.

## FINANCIAL ARRANGEMENTS:

If your child elects to take the college course for college credit only, you will have the financial responsibility for tuition, textbooks, materials, and fees. The District accepts no financial responsibility for those parents who will be paying for tuition, fees, or textbooks. Those arrangements are between the college and you and your child.

You and your child assume no financial obligations if he/she elects to take the college course for both college and high school credit. Tuition, textbooks, materials, and fees are assumed by the District. Should your child fail to complete a course taken for credit (non-passing grade or a "W"), any and all financial obligations assumed by the District will default to you and your child.

## **STUDENT CONDUCT:**

All Patriot students are held to the student code of conduct during College Credit Plus attendance, whether courses are online, at the university, or at Patriot Preparatory Academy. Students who are found to be in violation of the student code of conduct shall receive disciplinary consequences accordingly. Continued violations may result in dismissal from the program.
